Please bring the following to your intake:

1. Level I Program fee \$240 fee cash or check only. Please arrive on time there is a lot of paperwork to complete allow for 1 ½ hours for appointment.

2. Any *referral or paperwork from the Court of the State in which you received the offense. It must include: the court case number, controlling agency in sending state, their address, contact person, phone number, whether this case is supervised or unsupervised and whether you are on parole or probation, and whether this is a felony or misdemeanor. * Referral- including the complete contact information for your Probation Officer. - You **must** attend all 3 sessions for the program to be completed.
- If circumstances prevent attending one of the sessions, then your balance is transferable to the next available Level I program that can be attended.
- Please make sure that you supply us with your court case number, a contact name and fax number where we can to send your completion paper (DRS).
- All fees must be paid up before the final Level I group.

*Out of State Offenses: Clients will receive assistance to register with the Interstate Compact Commission. This is done at no additional charge. Interstate Compact requires referral or paperwork from the Court of the State in which you received the offense in, it must include: the court case number, controlling agency in sending state, their address, contact person, phone number, whether this case is supervised or unsupervised and whether you are on parole or probation, and whether this is a felony or misdemeanor. Clients must be approved by the ICC **BEFORE** you may attend group. This approval process is unpredictable, typically takes 1-16 weeks.
